## RE: Unconstitutional Restrictions on Photography and Filming at CBP Interior Checkpoint in Deming, New Mexico, NM Highway 11 between Mile Markers 12 and 13

Dear Chief Patrol Agent Hull:

We were surprised to see this sign affixed to the glass of the U.S. Customs and Border Protection (CBP) Interior Checkpoint in Deming, New Mexico, on New Mexico Highway 11 between mile markers 12 and 13:



The sign warns passersby in English and in Spanish: "No Camera, No Video, No Cell Phone" and "No Se Permiten Cámaras, No Se Permiten Videos, No Se Permiten Teléfonos Celulares."

And every federal court of appeals that has addressed this issue agrees: the First Amendment allows anyone to record on-duty law enforcement agents in public.<sup>1</sup>
