Expires: September 30, 2011

ARTICLE I
PURPOSE AND GENERAL BACKGROUND OF AGREEMENT

The purpose of this Agreement is to establish the terms, conditions, and safeguards under which the Social Security Administration (SSA) will provide Social Security Number (SSN) verifications to the (New Mexico Motor Vehicle Division) (hereinafter referred to as the MVA).

Under the national policy established by section 205(c)(2)(C)(i) of the Social Security Act (the Act)(42 U.S.C. § 405(c)(2)(C)(i)), States are authorized to use the SSN in the administration of their drivers' license laws for the purpose of establishing the identity of individuals affected by such laws, and may require any individual affected by such laws to furnish to the States (or any agency having administrative responsibility for such laws) his or her SSN.

As set forth herein, SSA will provide the MVA with SSN verification service via the Social Security Online Verification (SSOLV) process through the American Association of Motor Vehicle Administrators (AAMVA) for individuals seeking drivers' licenses and identification cards from the MVA. AAMVA's AAMVAnet™ network will serve as the conduit transmitting information to and receiving information from SSA on behalf of State MVAs that want to receive the verification service via an online mode. The MVA will transmit to SSA the name, SSN and date of birth for each verification request through AAMVAnet™. The result is a "match"/"no match" response and the reason for the "no match." This verification service will assist the MVA efforts to determine whether the identification information presented to the MVA by individuals seeking drivers' licenses and identification cards is correct.

The MVA acknowledges that SSA's positive verification of an SSN only establishes that the submitted information matches the information contained in SSA records, subject to the tolerances established in SSA's matching routines. The verification does not authenticate the identity of the individual or conclusively prove that the individual submitting the information is who he or she claims to be. As described herein, SSN verification does not constitute a matching program as defined by the Privacy Act, 5 U.S.C. § 552a(a)(8). SSN verification is not used to determine entitlement or eligibility of, or continuing compliance with statutory and regulatory requirements by, applicants for, recipients or beneficiaries of, participants in or providers of service with respect to cash or in kind assistance or payments under federal benefit programs, or recouping payments or delinquent debts under such federal benefit programs. However, this Agreement is executed under all of the other relevant portions of the Privacy Act of 1974, as amended, and the regulations and guidance promulgated thereunder.

ARTICLE II
DURATION OF AGREEMENT

The duration of this Agreement is 5 years, to be effective October 1, 2006 and to expire September 30, 2011. Parties to this Agreement may execute a new Agreement prior to the expiration date so that ongoing services are not disrupted. The terms of this Agreement are effective upon signature of both parties and the related reimbursable agreement, whichever occurs later.

This Agreement does not authorize SSA to incur obligations through the performance of the services described herein. Performance of such services is authorized only by the presence of a valid Agreement Covering Reimbursable Services (Form SSA-1235-U5) between SSA and AAMVA covering the Federal fiscal year in which the verification services will be provided.

ARTICLE III
MODIFICATION OR TERMINATION PROVISION

Either party may request modification to this Agreement at any time. Such a request must be in writing. Concurrence with a request for modification should be made within a reasonable time period. Any modifications to this Agreement must be agreed to by both parties in writing. Written notification of failure to reach agreement on a written request for modification constitutes notice of intent to cancel the Agreement, unless the requesting party withdraws the request for modification.

Either party may unilaterally terminate this Agreement by notifying the other party in writing of its intent to cancel the Agreement at the expiration of 30 days from the date of the notice or a longer period specified in the notice. The parties may confer during the period specified in the notice of intent to cancel for the purpose of resolving differences and reaching an agreement acceptable to both parties. Disputes may be referred jointly to the SSA Deputy Commissioner for Disability and Income Security Programs and the MVA official signing this Agreement for resolution. If the parties are able to resolve the dispute, the notice of intent to cancel will be withdrawn. If the dispute cannot be resolved, cancellation will be effective at the expiration of the period specified in the notice or such later period upon which the parties mutually agree.

SSA may, however, make an immediate, unilateral termination of this Agreement if SSA has determined that there has been: (1) an unauthorized use of the verification service by the MVA; (2) a violation of, or failure to follow, the terms of this Agreement; or (3) non-payment to SSA in accordance with the parties Agreement covering Reimbursable Services. SSA may also make an immediate, unilateral suspension of this Agreement if SSA suspects that the MVA breached the terms for security of data until such time as SSA makes a definite determination regarding a breach.

ARTICLE IV
LEGAL AUTHORITY

Authority for this Agreement is found in section 205 of the Social Security Act (42 U.S.C. § 405); 5 U.S.C. §552a(b)(3); and section 1106 of the Social Security Act (42 U.S.C. §1306).

Section 205(c)(2)(C)(i) of the Social Security Act (42 U.S.C. § 405(c)(2)(C)(i)) authorizes the States to use SSNs in administering their drivers' license laws by requiring any individual affected by such laws to furnish to the States, or any agency having administrative responsibility for such laws, his/her SSN.

SSA maintains a system of records named "Master Files of Social Security Number Holders and SSN Applications" SSA/OBEAS, 60-0058 (referred to as the "Numident"). Routine use number 33 gives SSA authority to verify personal identification data (e.g., name, SSN and date of birth) concerning individuals who apply for, or are issued, drivers' licenses or other identification documents by state motor vehicle agencies that issue such licenses or documents (60 F.R. 16155, March 29, 1995). In performing such "verification," SSA may indicate whether the identifying data furnished by the MVA concerning an individual match or do not match data maintained in this system of records, and SSA may identify the particular data elements that do not match. SSA will not disclose information from this system of records which does not match the information furnished by the MVA.

Section 7213 of the Intelligence Reform and Terrorism Prevention Act (IRTPA) authorizes SSA to add death and fraud indicators to the Social Security number verification systems for state agencies issuing driver's licenses and identity cards.

ARTICLE V
TECHNICAL SYSTEMS SECURITY PROCEDURES

The MVA must safeguard information provided under this Agreement by complying with the Technical Systems Security Requirements described in Attachment A.

To fully comply with SSA's security requirements and be permitted to connect to SSA through the AAMVA system, the MVA must submit to SSA a written security plan as described in Attachment A. SSA will review the plan and notify the MVA of its acceptance or whether there are any unresolved or unimplemented security control features. Such omissions must be resolved by the MVA before SSA will authorize their connection to SSA through the AAMVA system.

If the MVA is not in compliance with the attached requirements at the time this new Agreement is executed, SSA will approve the SSN verification request provided the MVA submits to SSA a plan to eliminate the deficiencies that is acceptable to the SSA Office of Systems Security Operations Management.

SSA and the MVA will adopt policies and procedures to ensure that information contained in their respective records and obtained from each other shall be used solely as provided under this Agreement and any applicable laws.

ARTICLE VI FUNCTIONS TO BE PERFORMED

The American Association of Motor Vehicle Administrators' (AAMVA) is hereafter deemed the "agent" for the MVA for billing purposes and AAMVA's AAMVAnet™ will serve as the conduit to transmit information to and receive information from SSA, consistent with the terms of this Agreement. AAMVAnet™ will transmit information to and receive information from SSA on behalf of the MVA.

SSA Responsibilities

SSA agrees to provide the MVA with SSN online verification service for the MVA's existing, renewal and new drivers' license (DL), and identification card (ID) records via direct terminal access through AAMVAnet™.

SSA agrees to compare the information furnished by the MVA with information in SSA's Master Files of Social Security Number (SSN) Holders and SSN Applications system of records. SSA will respond to the MVA through AAMVAnet™ with coded responses described in Attachment B.

MVA Responsibilities

The MVA agrees to provide to SSA the name, SSN and date of birth furnished by each person about whom SSN verification service is requested through AAMVAnet™.

SSA reserves the right to shut down the computer process between AAMVAnet™ and SSA with no warning and for an unlimited amount of time if SSA deems the process to be damaging the integrity of the internal, secure SSA Network.

ARTICLE VII
OTHER CONDITIONS

Certain State and Federal laws govern the collection of SSNs by the MVA. State and Federal laws also restrict the use and disclosure of SSNs by the State. Examples of these laws are found in section 7 of the Privacy Act of 1974 (5 U.S.C. §552a note) and 42 U.S.C. §405(c)(2)(C). The MVA agrees to collect, use and disclose SSNs in accordance with these laws.

SSN verification services are being provided under the terms of this Agreement with the understanding that the MVA will not use the fact of SSN verification as an enhancement to any information marketing efforts conducted by the State or its agents. If any such marketing effort occurs, termination of this Agreement under Article III will be considered.

ARTICLE VIII
RECORDS USAGE, DUPLICATION AND REDISCLOSURE RESTRICTIONS

The SSN verification information will be used and accessed by the MVA only for administering their driver's license and identification card programs.

The MVA agrees to the following limitations on access to, and disclosure and use of the information affected or created by this Agreement:

1. That the data provided as part of the data exchange will remain the property of SSA and will be destroyed or returned when the purpose for which the information was obtained is completed, but not more than 6 months after receipt of the data. The Privacy Act does not permit the parties to this Agreement to save entire databases after a computer match with SSA, but only to apply the specific data to the "matched" record.
2. That the data supplied by SSA and the records created by the data exchange will be used only for the purposes of, and to the extent necessary in the administration of the data exchange covered by this Agreement. The SSN verification information will be used and accessed by the MVA only for administering their driver's license and identification card programs.
3. That the data provided by SSA will not be used to extract information concerning individuals therein for any purpose not specified in this Agreement.
4. No other file will be created that consists of the verification information from SSA for redisclosure, duplication or dissemination within or outside the MVA without the written approval of SSA. SSA will not grant such authority unless (1) the disclosure is in compliance with the Federal Privacy Act (5 U.S.C. § 552a) and other applicable Federal laws and regulations; and (2) the disclosure is required by law or is essential to the matching activity. For purposes of this Agreement, the definition of the term "essential" that is set forth in the Computer Matching and Privacy Protection Act of

1988, as amended, and the guidance promulgated thereunder, will be adhered to for purposes of administering this provision. In such instances, the MVA must specify in writing what file is being disclosed, to whom and the reasons that justify such redisclosure.

ARTICLE IX
REFERRAL OF INDIVIDUALS TO SSA

If the SSN given by the individual does not match SSA's records, the MVA should take the following steps before referring the individual to the SSA field office:

1. The MVA should recheck their records to be sure that the original data submitted to SSA has not changed; e.g., last name recently changed.
2. The MVA will recontact the individual to verify the data submitted is accurate.
3. The MVA will consult with the SSA Project Coordinator to discuss options before any mass mailing occurs advising individuals to contact their SSA field office for resolution.

Note: Issuance of new or replacement Social Security card usually takes two weeks.

ARTICLE X
REIMBURSEMENT

The MVA will make payment to SSA through AAMVA. AAMVA will be responsible for coordinating with the MVA all billing and collection information. For billing and collection purposes, SSA will deal directly with AAMVA. AAMVA will provide SSA with advance payment for all services rendered under this Agreement. Payment will be made to SSA pursuant to the Agreement for Reimbursable Services (SSA-1235-U5) between AAMVA and SSA.

The reimbursable amount due SSA is determined by the full cost of the volume of SSNs that are submitted to SSA on a fiscal year basis.

The cost estimates by SSA to enter into this Agreement were calculated using the current Federal fiscal year rates and will change in the next fiscal year. The actual cost incurred will be computed using the current year's rate.

SSA may make an immediate, unilateral termination of this Agreement for non-payment to SSA pursuant to the terms of the Agreement between AAMVA and SSA, and/or for non-payment to SSA in accordance with the terms of this Agreement.

SSA will enter into an Agreement Covering Reimbursable Services, SSA-1235-U5, with AAMVA for online SSN verification services. Any fees charged the MVA by AAMVA for services it provides on behalf of MVA are the sole responsibility of the MVA and AAMVA and are not covered under this Agreement.




